## REQUIREMENT FOR AN AFFIDAVIT OF RESIDENCY TO QUALIFY FOR REDUCED RENTAL FEES

In conjunction with the Cambridge Public Schools Community Use of Facilities Policy, the Cambridge School Committee has established a category of renters of school facilities for the purpose of assessing reduced rental fees. Included in this category are: individuals who live in Cambridge; Cambridge-based 501(c)(3) organizations; and non-commercial organizations, groups or clubs comprising a membership of at least fifty percent (50%) residents of Cambridge, Ma. In order to qualify for this category, a renter must complete and sign an affidavit of residency.

#### **PROOF OF RESIDENCY**

Any one submitting an affidavit or residency for the purpose of qualifying for reduced rental fees <u>may</u> <u>be asked</u> to provide proof of residency. The following documents will be accepted:

Forms of proof of residency include the following: For individuals who live in Cambridge - Lease, Section 8 Agreement, Purchase & Sales Agreement, Mortgage Statement, Deed, Letter from Homeless/Transition Service Provider, or Tax Bill and one the following document dated within 30 days establishing proof of occupancy - Gas bill, Oil bill, Electric bill, Cable bill, or Homeless/Transition Service Provider Letter; For Cambridge-based 501(c)(3) organizations - Lease, Purchase & Sales Agreement, Mortgage Statement, Deed, or Tax Bill and one the following document dated within 30 days establishing proof of occupancy - Gas bill, Oil bill, Electric bill, or Cable bill; and for non-commercial organizations, groups or clubs comprising a membership of at least fifty percent (50%) Cambridge residents Lease, Purchase & Sales Agreement, Mortgage Statement, Deed, or Tax Bill and one the following document dated within 30 days establishing proof of occupancy - Gas bill, Oil bill, Electric bill, or Cable bill and membership roster for this non-commercial organization, group or club for the time period related to the rental of school facilities establishing a membership of at least fifty percent (505) Cambridge residents.
